

# **Shakin Shuttle Party Bus LLC**

## **Rental Contract**

**Shakin Shuttle Party Bus LLC is only insured in the State of Illinois, we DO NOT travel out of State.**  
**Renters PLAY their own music through Bluetooth.**

### **Renter Eligibility**

Renter must be 21 years of age or older.

Renter responsible for making sure there is no underage drinking on the bus.  
Shakin Shuttle Party Bus and/or the driver is not responsible for any underage drinking.

### **Bus Deposit**

The deposit check of \$100.00 must be received within **7 days** of making your reservation or the reservation will be considered canceled. All deposit checks will be held until after rental date. As long as there is no excessive clean up, and or damage deposits will be returned within 10 days following your rental date.

**Check deposits will be shredded after your rental if not applied to unpaid time or damage.**

**\*\*Deposit forfeits include but are not limited too; vomit, human feces, Jello/Pudding cups, broken glass!**

**Credit card information is to be filled out incase of excessive damage and or cleanup. You will be notified of charges before amount is charged, the following day after event.**

If reservation is cancelled more than 60 days before your date, deposit is refunded 100%. Any cancelation made by the renter less than 60 days before event date is forfeited to the company. If company makes a cancelation due to mechanical or weather related issues, deposit is refunded 100%.

### **Payment**

Full payment in **cash or venmo** must be received prior to boarding the bus. Payment can be made by check in advance, but the check must be received at least 14 days prior to your event date, to allow clearing at the bank. Checks, money orders, credit cards are not accepted as payment on the date of event.

**\*Fuel charge is determined by pick up location, and to be paid with amount due before boarding.**

### **Alcohol Policy**

**Anyone consuming alcohol while on board the bus MUST be 21 years of age or older.**

Alcoholic and non-alcoholic beverages are permitted. Beverages should be brought on board in solid coolers (no soft side, Styrofoam, or damaged coolers will be permitted). No bottles will be allowed.

Cans and plastic containers are welcome. **ABSOLUTLEY NO GLASS, JELLO OR PUDDING SHOTS!**

**ANY GLASS CONTAINERS AND THE BUS DEPOSIT IS AUTOMATICALLY FORFEITED!**

**THE SHAKIN SHUTTLE PARTY BUS LLC IS NOT RESPONSIBLE FOR ANY UNDERAGE DRINKING.**

**ABSOLUTLY NO SMOKING ON THE BUS.**

Please be considerate of your fellow passengers.

Violation of the following will result in immediate termination of the bus run.
